Official welcome and opening of meeting by Vesna Stefanovska

- short self-presentation by the participants
- short presentation about the Macedonian prison system by the host organisation, Faculty of security Skopje

Presentation of the local activities of the project partners – Gert Hurkmans

- Gert went through the separate folders in the Google drive and all partners agree to put in order their materials, documents so that they can be more easily put on the project website's folder which will be systematized by Romy.
- Macedonian partner will write the 4th Newsletter.
- After piloting sessions, each partner is expected to give same recommendations related to the application of the task sheets for adult educators.
- Recommendation to write scientific paper about the SOCVOC project and to publish in some journal.
- All partners agree all materials on the socvoc web site to be only in English.
- Recommendation to use epale.ec.europa.eu (Electronic Platform for Adult Learning in Europe) and to publish certain information about the SOCVOC project. Each partner organisation is allowed to write on that platform.
- Short discussion among the participants about the VET in prison and issues related to motivation of both, the educators and the prisoners to teach and to take some training courses in prisons. Each partner organisation has different experiences.
- All partners to upload at least three online exercises/games linked to the 21st century skills which can be used for self-study by prisoners/students.

Dissemination: presentation of dissemination related actions and distribution of responsibilities.

- Recommendation for the multiply events to be connected with the project WP in order to multiply the results and to disseminate them to bigger audience related with prison education.
- The last four months (July-October) to be used for dissemination of the project results, activities and inputs.
- Proposal by Polish partner organisation to have joint multiply event in Poland together with the last transnational meeting the last week in September, 2024.
